A great lawyer is like a bricklayer. Learn how...

Do you know why a really good trial attorney is almost like a bricklayer? This is a really important explanation that tells you why it is so important for an attorney to be like a bricklayer. Come join me for a moment as I share with you this great information.

Hi, I'm Gerry Oginski. I'm a New York medical malpractice and personal injury attorney practicing law here in the state of New York. A bricklayer creates a home. How do they do that? What's the first thing they work on? They work on the foundation. Once they have the foundation built for a nice, strong foundation, a nice, strong base, they go ahead and put the bricks on one-by-one. Painstakingly, one-by-one-by-one and now they put the cement in-between.

An attorney at trial has to do the same exact thing. An attorney has to lay a foundation for the entire case. That forms a clear, strong base and then each piece of evidence, each piece of proof, gets put in into nice slots one-by-one-by-one and now they get filled in. Instead of using cement, they get filled in with the testimony. Each piece of evidence, each exhibit, each piece of proof, has to go in one-by-one-by-one the same way that a bricklayer puts together a home to create a strong foundation with a strong outside so that now nothing's going to knock it down. Cross-examination won't destroy it. No matter how much he puffs, no matter how much hot air comes out of the defense attorney, that strong foundation will hold up. The testimony will hold up.

There are a lot of analogies that can be made between a bricklayer and a trial attorney. Even though a trial attorney is not getting his hands dirty and they're not calloused, the reality is that a good trial attorney has to establish a foundation, he has to go ahead and establish each and every piece of evidence. Unlike what you see on TV or in the movies where an entire case is proven within one hour or ninety minutes, in a real trial, in a civil case that goes to trial involving an accident case or a medical malpractice case or a wrongful death case, it will often take days and days in which to get out all

the necessary evidence to prove that we are more likely right than wrong, that what we are claiming is true.

Why do I share this quick analogy with you? I share it with you just to give you an insight and an understanding into how these cases work here in New York. I acknowledge and I realize you're watching this video because you likely have questions or concerns about your own particular matter.
