DEFINITIONS

1. PLAINTIFF: A person who brings a lawsuit
2. DEFENDANT: A person who is being sued
3. DEPOSITION: A question and answer session where the attorney for the other side gets to question you about your claim. Your lawyer will also have an opportunity to question the people you have sued.
4. OBJECTION SUSTAINED: The witness is not to answer the question as there is something wrong with the question.
5. OBJECTION OVERRULED: The witness can and will answer the question despite one attorney objecting to the question.
6. LEADING QUESTION: Where the attorney suggests the answer in the question. For example, "Isn't it true that the light was green when you went through the intersection?" A non-leading question would be "What color was the light when you went through the intersection?"
