Doctor admits liability at trial. Will he now lose his license to practice medicine?

If I get the doctor to admit during his medical malpractice trial that he violated the basic standards of medical care, at the end of the trial will the doctor lose his license to practice medicine?

Do you want to know the answer? Do you think you know the answer?

Come join me for a moment, as I share with you, some terrific information.

Hi, I'm Gerry Oginski, I'm a New York, medical malpractice and personal injury attorney, practicing law here in the state of New York.

The answer is no, the doctor is not going to lose his license, even if thee jury determines that the doctor violated the basic standards of medical care. You want to know why? It's because the issues surrounding the civil lawsuit are entirely different then the issues about whether or not the doctor continues to practice medicine. The New York state department of health, and the medical board that governs doctor licensing.

They use different standards to determine whether or not the doctor is an imminent danger to patients, to be able to treat patients. Compare that to the claims that are made by an injured patient. When an injured patient brings a lawsuit against a doctor for medical malpractice, the goal of that lawsuit is not to get that doctor's license revoked, it's not to get his license suspended. Instead it's for one purpose only, to confirm that what he did is improper, and to obtain

compensation for all the harms, and all the injuries that the doctor caused, as a result of the doctor's wrongdoing. That's the goal.

They're two different goals when evaluating whether or not the doctor is an imminent danger to patients, that the New York state department of health has to evaluate. Compare that to a civil lawsuit, where a patient is trying to obtain compensation, for all the harms and injuries that were caused by the doctor, so they're two totally separate things.

The reason this comes up is because there are some patients who come into the office, that they are so angry, and their sole focus is, "Listen, I want to bring a lawsuit, because I don't want this doctor ever to practice again". Well, I have to teach them, I have to explain to them, that when you bring a lawsuit, it is not for the purpose of getting the doctor's license revoked, or suspended. Instead it's to obtain compensation for you and your family, as a result of the injuries that you suffered.

So, why do I share this great information with you?

I share it with you, just to give you an insight, and an understanding, into as to how these cases work, here in New York. You know I've realized you've been watching this, because you have questions, or concerns, about your own particular matter.
