Doctor, is the reason why you're no longer doing obstetrics because of that \$10 Million verdict against you?

Now, this is a gynecological case, and now I had an opportunity to question the gynecologist who we believe violated the basic standards of medical care. That's a question and answer session where I get to ask the doctor questions in her lawyer's office, and now her answers form the basis of her testimony. That carries the same exact weight as if she is testifying at trial.

In the days leading up to that pre-trial testimony, I did a tremendous amount of research, and I learned that this doctor had been involved in another lawsuit that had gone all the way to trial. Not only that, but the jury determined that this doctor was legally responsible to pay 10 million dollars, in addition to two other doctors, to the family of this baby who suffered significant brain injury.

Now I had tremendous information that I needed to ask the doctor during our case, and one of the things that I asked her during the course of my pre-trial question and answer session was, "Doctor, is the reason why you are no longer performing obstetrics because of this jury verdict of 10 million dollars against you and your partners?" She looked at me. She was totally shocked, and she said, "How did you know about that?" Her attorney, correctly, turned to her and said, "Doctor, don't worry about how he knows this information. Just answer the question." It turns out, the doctor says, "No, that had nothing to do with it."

What did I do when I learned that information? Did I cross-examine her on that issue? The answer was no. I didn't need to. I simply wanted to know whether or not

that particular verdict played any part in her decision not to continue doing obstetrics. Now, it was interesting that about the time that she stopped doing obstetrics was about the time that she got this jury verdict. I know that her attorney told her during a break that as part of the research that we do prior to coming in and questioning the doctor is we learn whether the doctor's ever been involved in any prior lawsuits. If she has, or if the doctor has been, we want to know which cases. We want to know what the result was. We always want to get the trial transcript of what it was that she testified about, because there might be nuggets of information in there that we can use in our case.

Why do I share this quick little story with you? I share it with you just to give you an insight and an understanding into one particular case where I questioned the doctor, and now the doctor turns around and says, "How did you know about that?" Simply, because of the research we had done in days leading up to the pre-trial questioning.
