SOME HOLIDAY THOUGHTS

Holiday cards:

I say this every year. Do you really need a pre-printed card with a generic holiday scene that says the same thing every year? I don't think so. Think about why you send out a holiday greeting to begin with. You want to send good wishes to your friends and relatives, right? I've got a better idea. Why not send a handwritten note expressing your real thoughts during this holiday season?

Getting a hand-written letter is so much more meaningful than a standard-issue, generic card which says nothing. That's my opinion, even though my wife always disagrees with me.

Holiday Accidents:

Along with family gatherings and enjoying the holidays together, there is someone, somewhere, drinking too much. Despite tougher laws that crack down on drunk driving, it still happens. You must be evervigilant when driving during the holidays. You do not want to be another statistic with your family in tears.

Lawyer advertising:

When you watch a TV ad for a lawyer advertising their services, ask this one word at the end of every commercial you see: *WHY*?

Why should you hire that lawyer? What information has that lawyer given you in their 30 second commercial that would give you the slightest bit of useful information that would allow you to know if that lawyer was the right one for you? The answer: They've provided you with <u>nothing</u> to educate you and make you a better-informed consumer of legal services.

Frequently Asked Questions You Need To Know About

Q: "If I was in a car accident, how much time do I have to file a lawsuit in New York?"

A: Generally, you have 3 years. Children have a different time limit. You must file a claim with your no-fault insurance within 30 days of the date of your accident.

Q: "How much are we suing for?"

- A: In a medical malpractice case, we are not permitted to put an actual number that reflects the amount we are suing for. That is for the jury to ultimately decide. In a personal injury or negligence case, we must put an amount down. It is no secret in the legal community that the amount demanded in your lawsuit papers bear no real relation to your actual damages.
- Q: "Why do we need an expert in a medical malpractice case?"
- A: Two reasons: (1) To confirm that you have a valid basis to bring a lawsuit, and (2) To help a jury understand just what medical care and treatment you had; what was done wrong; what should have been done differently; and how treating you differently would have changed your outcome.

Q: If a doctor left a foreign object inside of me during surgery, how much time do I have to start a lawsuit?

A: In New York, you generally have only one year from the date of discovery of this foreign object in which to start a lawsuit. Importantly, if the foreign object was intentionally left inside of you during the procedure, you will probably not be able to start a lawsuit, even though you just learned about this foreign object now. There are recent New York cases that have held if the object was NOT supposed to remain inside of you then you would have only one year from the date of discovery of the foreign object within which to file suit.

Q: I've heard the phrase 'loss of enjoyment of life' - what does it mean?

A: That is a concept that lawyers use to explain that your injuries caused you pain, suffering, and literally the loss of enjoyment of your daily life. This allegation of loss of enjoyment of life is included within any claim for pain and suffering you may have. We would point out to a jury how your injuries have affected your daily lifestyle, how you are physically disabled from doing those daily tasks that were once simple and easy, and how you no longer enjoy your lifeas you once did, because of your debilitating injuries.

Q: What does it mean when a lawyer is suing for 'damages'?

A: Damages means your injuries. Your injuries include those which are 'visible'- that you can see; those that are invisiblethose you cannot see; physical pain and anguish; emotional pain, sorrow, anxiety, humiliation, anger, fear, frustration; an inability to do those physical activities you used to do (sports, gardening, music, cooking, etc.); an inability to socialize with friends and family; an inability to interact with your family; changes in your daily lifestyle; the need for medical treatment and visits to doctors; the need for future medical care; medical expenses; prescription medications; household help; loss of income in the past and future and similar types of damages.

Q: My car was totaled in a car accident. My insurance company wants to pay for the car and then get rid of the car. Should I allow this?

A: The most important thing is to take pictures of your car before the insurance company disposes of your totalled car. It will be extremely important to show what your car looked like after the accident.

Q: What does it mean when a judge says "Objection Sustained"?

A: It means that one party has objected to the question. It also means that the judge has decided that the attorney asking the question CANNOT ask the question, and that the witness is NOT to answer the question.

Frequently Asked Questions You Need To Know About



Fact: You are sitting in your

car on the drive home from work listening to your radio. You hear a 15 second commercial for an attorney that blasts their 800 number six times in the space of 15 seconds. The number stays in your head for about 2 1/2 seconds and then you continue paying attention to the road and the music you were listening to.

Fact: At that moment, you had no need for a New York accident or medical malpractice attorney. Will you remember that 15 second commercial?

Let's assume for a moment that a family member was recently involved in an accident or suffered harm because of a doctor's wrongdoing. Their injuries and disability are weighing heavily on your mind. On the way to work, again while listening to the radio, you hear another ad for an attorney in your area. In the space of 15 or 30 seconds they tell you how long they've been in business and what type of law they handle. Again they blast their 800-number repeatedly in an attempt to get you to memorize it on your drive to work.

Ask yourself this question if you've ever heard those lawyer commercials:

"How do I know that this law firm is right for me just based on the 15 second or 30 second ad I just heard?" Here's another question you should ask: "What information has been provided to me that helps me distinguish this law firm from any other law firm I've seen advertised on TV, in the newspaper or on a billboard?"

In all likelihood, you will be unable to answer those questions.

Here's another question: "What information has the law firm provided to you that helps you understand how they can solve your legal problem?" Other than telling you that they've been in business for 'x' years and that they handle personal injury law, why are they any different from the 10 other law firms you also heard about on your way to work?

The problem is with the message and not the law firm. In the span of 15-30 seconds, it is impossible for anyone to provide you any real useful information that will help you distinguish intelligently how one particular lawyer can help you compared to any other lawyer. You should know that lawyers in NY are not allowed to compare themselves to other lawyers in their advertising. For example, a lawyer cannot say "we're better than John Smith's law firm because..."

Does this mean that you should not go to any lawyer who advertises by radio? No, because there may be a lawyer who advertises by radio ads that might be the perfect person to represent you. On other hand, you don't have any real information to help you and guide you to make an intelligent decision about whether that lawyer is right for you.

The bottom line? Radio ads fail miserably to provide you with any useful information that will help educate you when deciding whether a particular law firm is right for you. You need to know that any law firm you go to has the ability, experience and the drive to help you in your particular case. How do you find that information out? Not with a 15 second radio ad; that's for sure.
