Nurse was screaming at me in the ICU while I was taking pictures

The nurse started screaming at me in the Intensive Care Unit that I'm not allowed to take pictures of this patient. You want to know what this is all about, and why I was in the Intensive Care Unit taking pictures? Come join me for a moment as I share with you some remarkable information.

I received a phone call from a very distraught family telling me that they believe that their had significant injury, and likely is going to die, as a result of improper medical care at this particular hospital in New York. I arrived in the Intensive Care Unit, and that's exactly what I saw. He had every sort of tube, and electronic machine beeping, and now he's sitting there in a coma. He's sitting there not breathing for himself. He's sitting there with an EKG machine monitoring his life support, his vital signs. The family is distraught and they begin to tell me the story of what happened to him in the hospital.

Now I'm listening to their story and it's tragic. It's horrible. They asked me, "Could you please take some photographs, so that we can recall, and remember him now before he ultimately dies." The doctors were telling this family that in likelihood this young man was going to die within either a few hours, or a day or two, and they wanted something to remember him in his last moments. I took out my camera, and now I started taking pictures. A nurse in the ICU sees me, comes running in, and she starts screaming at me. "You can't do that. You're not allowed to do that. That's violating hospital protocol." I looked at her and I said, "Excuse me. Who are you?" I said, "What's your name?" I was very calm, and very polite. I told 'em my name. I gave

her my card. I say, "I'm the attorney for this distraught family. They've invited me here. They asked me to come and chat with them, and they also asked me to take photographs of their son. Do you have a problem with that?"

Now she started again yelling and screaming, saying that I couldn't do that. I said, "Here's what we're going to do. If you like you're more than welcome to contact whatever hospital administration people you like, and invite them to come up, and have a chat with us. Since I'm representing the family, and now I have an opportunity to talk with them ... In all likelihood this young man is going to die in a few hours or days ... I feel it's important and critical to take a few photographs. Do you have a problem with that?" The nurse got all upset even though she recognized what I was doing. Ultimately this young man did in fact die a few days later, and now the family had a number of photographs to remember him, even though it was not the ideal situation.

Why do I share this quick story with you? I share with you just to give you an insight, and an understanding into what went on. In one case I was able to help a family obtain significant compensation for all the harms, and losses, and injuries that they experienced, as a result of their young son dying at an early age.
