What's this lawsuit about? Defense attorney asks

Two weeks after I started this medical malpractice lawsuit, the senior partner in a very well-known Manhattan defense firm calls me up and says, "Gerry, can you tell me what this case is about?" The answer is, they do that but it takes a bit of time for them to get going. Then, he give him the low-down, give him the information dump about exactly what had happened. Now, when he's

representing the hospital, he only has a vague idea about what the real issues are.

Instead, to short circuit the whole process, he picks up the phone, calls me and in the span of two minutes, I tell him exactly what the claim involves, I tell him what the issues are and I tell him what injuries my client has suffered. That is a tremendous thing to do if you have that relationship with the defense attorney, you've worked with them before and now, he takes that extra step to pick up the phone and says, "Hey counsel, can you tell me what this case is really about?"

Now, the next phase of that case involves providing a detailed itemized list of the allegations against his particular client so that now, he will have a better understanding and he can send those papers off to the insurance company as well.
